COURSE INFORMATION

Description

The course examines the contrasting and sometimes conflicting Zionist ideologies that expressed the nationalist hopes for the Jewish people, and a general history of the modern state of Israel from 1948 to the present. Particular attention is given to the ways in which Israel has defined itself as a Jewish state, the role of religion in Israeli politics, law, and society, and the challenges to this identity, including the multiple forms of Jewish identity represented in Israel (e.g., secular, Haredi, Mizrahi), and the presence of a large number of non-Jewish, Arab/Palestinian, citizens.

To describe the various forms of Zionist thought, the differences among them, and the objections to Zionism.

To understand the basic history of the modern state of Israel, its people, society, and culture, from 1948 to the present.

To analyze the understanding of Israel as a Jewish and democratic state, and what this means for the identity of the Israeli polity, and in particular for non-Jews who are citizens.

To understand the role of religion in Israeli history, politics, law, and society.

To voice informed opinions on the relations between Israel, Palestinians, and Arab states, and the factors that have contributed to the hostilities, and the possibilities for peace.

3. Position papers (60 points)

In a concise paper (one page, single-spaced), respond to the questions posed in the syllabus. Your papers are due by noon on the day of discussion. You may also wish to bring a copy of your paper to class to consult during the discussion.

4. Research Paper (200 points)

Complete a research project on some aspect of Zionism or Israel. The research project affords you the opportunity study a particular aspect of the course in greater depth. You should engage this project as an on-going assignment that you develop over the course of the semester. This is meant to be an analytical paper, not a report. You paper should ideally be trying to answer a particular question or address a specific topic.

Submit a brief paper (one to two pages, single spaced) identifying the general area or topic on which you intend to work and some of the issues you intend to examine.

Stage 2: Annotated Bibliography: due TBA (15 points)

Prepare an annotated bibliography (i.e., full citation with a brief paragraph describing the contents and its importance for your research), including at least five relevant sources beyond those listed in the syllabus. At least one of the entries must be a monograph (i.e., book with a single author) and one a scholarly article (i.e., from an academic journal or collected essays). Please include a brief description (three to four sentences) of your project.

Stage 3: Final paper: due TBA (175 points)

The final research paper should be approximately 12-15 page paper (double spaced) in length.

Please observe the following conventions when submitting your work:

- Use one-inch margins.
- Use Times Roman, 12-point font.
- Include page numbers.
- Citations may appear as footnotes, endnotes, or parenthetical form. Be consistent.
- Include a bibliography using an appropriate style.

Guidelines for writing the paper:

- 1. Present an clear argument or point of view that seeks not only to describe but to persuade based on an explanation of the evidence.
- 2. Be focused. You may want to provide some general or background information, but the majority of the paper should focus on the particular topic.
- 3. This is an *academic* paper that should reflect an understanding of *academic* discussions. While the internet contains many sites that provide basic information, good analysis usually takes place in journal articles, books, and other scholarly writings.
- 4. Watch the mechanics. Proofread your paper for grammar, spelling, and style.
