Readings in Israeli Society and Cultures

This is a course for graduate students. These are some of the over-arching questions for the course, and please be prepared to relate the reading assignments to these questions in our class discussion.

- (1) What is Zionism? Where was it anchored in the intellectual vista of the modern European nationalism? What are the main manifestations of the Zionist discourse in the State of Israel?
- (2) To what extent can Israel be described as a Jewish and democratic society? What are the main features of the Israeli Society?
- (3) Like other modern nationalistic movements, Zionism has its archaic facets in the process of its nation-building, trying to legitimize itself with a remote and rosy past. How has it reclaimed a Jewish "usable past"? What are the tensions between tradition and innovation in doing so?
- (4) Whether is that which is Jewish tantamount to that which is Israeli?

Requirements and Evaluations:

- Reading: Students MUST attend class having read the assigned readings each
 week and having prepared thoughtfully to discuss the issues raised. This will
 be measured through summarizing the major points and arguments of the
 readings.
- Attendance: One absence will be considered unremarkable. More than two absences will require explanation and will affect the final grade.
- Participation: The course will emphasize discussion. Full participation is expected.
- Presentation: Each student will make a presentation of at least 30 minutes on a topic of his/her choice.
- Final paper: The paper, with minimum 4,000 Chinese characters, should be based on the presentation. It is expected to be fully annotated and included with a bibliography.
- Grading: attendance 10%, class participation 30%, presentation 20%, and final paper 40%.
