

## Introduction to Israel Studies

For each class, there is a **essential** (“**texts to be analyzed in class**”) and **additional** reading. For each class, **the students are obliged to read the essential texts**, consisting mostly of primary sources in English (historical speeches, excerpts from key documents and proclamations, articles of important Israeli thinkers etc.). The additional reading is recommended for those with deeper interest in the topic or those, who missed the particular lecture

### Requirements:

Active participation in the classes and the discussions, based on reading of the compulsory texts.  
Completion of a written assignment. Oral exam.

### Written assignment:

1. Select a topic of your choice that is related to contemporary Israel: cultural life, political life, ethnic tensions, religious vs. secular, economic and social situation, Bedouins, settlements, Art...
2. On the first lecture, suggestions of Israeli media in English will be given.
3. Follow these media (and others you may find) and write a **three page analytical essay in English** on what is the situation like in your selected field, what are new trends and events, what are the future prospects, what threats or challenges you see etc.

## First seminar - Introduction

**Course introduction**, Israel as a field of study. Sources of Information and how to read them (example of various discourses by means of analyzing the Wikipedia entries in seminar), Explanation of course requirements. Terminology. Proper pronunciation of Hebrew and Arabic names. (discussion with the students on motivations to enlist Israel study course)

**Meet the State of Israel** - Political and constitutional system. Jewish? Democratic? Basic division of Israeli society. Social and demographic paradoxes. Basic overview of Israeli and Palestinian Topography (cities, mountains, key historical places, explanation of specific geographical terms). Geographical paradoxes of “Biblical” vs. “Modern” Israel.

### Texts to be analyzed in class:

If the student is experienced with how Wikipedia works, it is highly recommended for him to view over the history of changes in this particular entry. Try to compare the entry in different languages as well (Czech vs. English vs. German vs. French vs. Hebrew vs. Arabic)*

Israel, look into the section “transnational issues”, which are chosen and how are those explained.

## Second seminar - Birth of Zionism and the State-on-the-go

How to define Zionism?, Roots of Zionism, Forerunners of Zionism, Zionism and its Competitors, Early Settlements in Palestine. The Yishuv – Colonists or Refugees? – social situation, language, struggle for distinctive cultural identity.

## Fourth Seminar – The Crossroads of Refugees

The “War of Independence” and its aftermath. Palestine as a crossroads of refugees, Jewish and Arab, incoming and departing.
